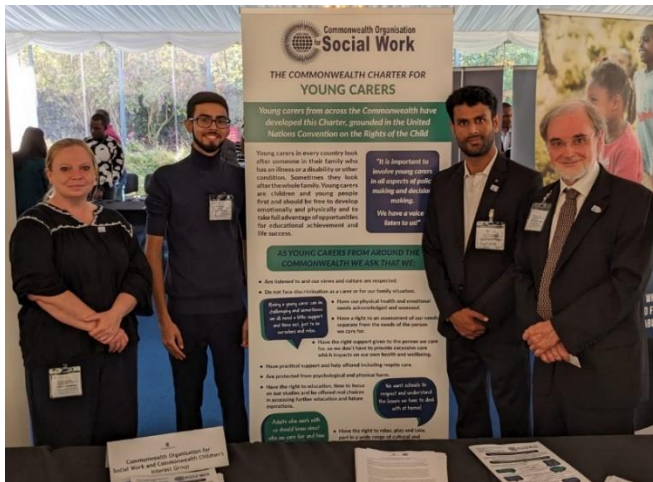

SPEAKER BIOGRAPHIES

Matthew Neuhaus has served for many years in the Australian diplomatic service, including periods in Kenya, Papua New Guinea, Nigeria and Zimbabwe. He served Australia at the United Nations and in October 2002 was appointed Director of the Political Affairs Division of the Commonwealth Secretariat in London, helping to organise three CHOGMs – Nigeria (2003), Malta (2005), Uganda (2007). He also oversaw Commonwealth democracy and election work, and was involved in conflict resolution in Pakistan, Fiji, Kenya, Guyana, Maldives and Tanzania/Zanzibar. He recently retired following a period as Ambassador to the Netherlands. Matthew will share his wide experience of and academic research on social policy in the Commonwealth.

Joachim Mumba is the IFSW President (2022-2026) and has been Secretary General of the Social Workers' Association of Zambia since 2005. He is also a COSW Board Member. He was instrumental in successfully negotiating the Social Workers' Association of Zambia Act, which was signed into law by the President in 2022. Joachim has been involved in a study landscaping the social welfare workforce and the extent to which social work is being recognized as a profession in Africa. This exercise was done in partnership with UNICEF Eastern and Southern Africa (ESARO) and the Global Social Service Workforce Alliance (GSSWA). He describes himself as a social work Ubuntu practitioner. Joachim will comment on the common objectives of IFSW and COSW.

Dr Janneth Mghamba is the Health Advisor for the Commonwealth Secretariat and former assistant director for the epidemiology and disease control section of Tanzania's Ministry of Health. Her current area of focus is on assisting Commonwealth countries to achieve Universal Health Coverage (UHC) goals by addressing inequity and disparities; building their digital platforms to strengthen health outcomes; addressing Global Health Security; NCD and Cervical cancers and the major ATM diseases. Janneth works alongside Advisers on education and youth services and will share an overview of current Commonwealth social policy activity.

Mario Gerada is a social worker based in Malta, a senior manager in the Migrants Commission of the Catholic Archdiocese of Malta and a Civil Society Advisory Governor of the Commonwealth Foundation. He has extensive experience of front-line human rights work with a special focus on migration. He has personal experience of the importance of constructive engagement between government and civil society, gained through his leadership within a national civil society organisation. He played a key role in the 2015 CHOGM People's Forum in Malta. Mario will talk about the experience of CHOGM 2015, the Commonwealth Foundation's critical dialogue programme and plans for CHOGM 2024.
